About Project on Capacity Building & Skill Development Programs for Tribal Communities in Maharashtra

The *Centre for Emerging Economies at MM's IMERT* has received grants of **Rs. 25.34** lakh from Tribal Research & Training Institute (TRTI), Government of Maharashtra to conduct various research projects and carry out capacity building & skill development programs for the members of tribal communities in Maharashtra.

These projects aim to benefit around 3000 tribal people directly to provide them sustainable livelihood in a span of two years. It is targeted at honing the prodigious skills of these communities imbibed in their rich primordial art & culture and taking them to the national & international markets.

The students of our post graduate courses would be working on it. The students would be exposed to field work & conduct empirical studies to develop a market oriented business model. This would offer our students to understand the intricacies of society as well as the business. The first visit of our students to tribal area in Palghar District of Maharashtra is scheduled in second week of January 2020 to conduct studies.

About Centre for Emerging Economies at MM's IMERT

The Centre for Emerging Economies (CEE) at MM's IMERT was inaugurated by the hands of **Hon. Dr. Pami Dua**, Member of Monetary Policy Committee in the year 2019. **Padmabhushan Shri. Madhav Gadgil** is the 'Honorary Advisor' of the Centre.

It is envisioned as a liberating space with no disciplinary boundaries for the conduct of research, projects, academic experiments, interactions, events and publications. It is dedicated to conduct empirical interdisciplinary studies in the allied domains of economics concerning to the contemporary issues. Focusing on India and its intricacies that are diverse from the rest of world, the center strives to instil a broader perspective to its students through a host of research activities.

Few of the studies/projects underway:

- Social Impact Project on Socioeconomic Development of Tribal Community in Palghar District (of Maharashtra): The center has recently received a grant of INR 25.34 Lakh for taking up study and developing a business model for providing a sustainable livelihood to tribal communities in this region. The project thus started as 'pilot project' for this year is to be expanded to cater other (tribal) districts in Maharashtra.
- **Empirical study of present state of auto industry in Pune and their remedies** The study limits to understand the causes and possible actions that can be taken up at the policy level to address the issues pertaining to this industry.
- Comparative study of stress as a dysfunction among organized & unorganized sectors -This study taken up by some of our students is to be further extended to profiling both these sectors. The study is carried out under the guidance of some of the psychologist in the city.
- A study of markets from the lenses of behavioral economics A group of students working on this project are keen to give their assessment of markets to industry in a form of a Working Paper.

7.To give feedback on the review and incorporation of suggestions as given by end users/stakeholders to better equip them for prospective benefits arising out of success parameters mutually defined by the both the parties this may also include application of research studies, creation of IP, Collaboration with host/endorsement institutes etc..

8. To collect necessary information for research projects in IP creation, involvement of manpower in research activity, field visits, literature survey and link them with the disbursal of funds so as to ensure quality project completion.

9. To conduct periodic inspections and verify the documents, infrastructural change if effected by the training partner to ensure the quality and final outcome of research projects. To give feedback for incorporation of changes/modifications for ensuring deliverable committed by research agency/individual.

10. To hold meetings/discussions of party of second part jointly with end users/stakeholders in research project and ensure optimum resource utilization for tribal welfare.

Role and Responsibilities of Party of Second Part:

1. To prepare and submit the proposals as per affiliations secured by the party of second part aligning same with the mandate of both the parties.

2. To report in writing the mandatory requirements/ affiliations for the fulfillment of project with respect to accounts and audit needs of funding agency

3. To organize the human and material resources as per the standards of affiliating agency or multiple agencies as per the nature of research project

4. To complete the procedural formalities for establishing R & D centre which may be required by different Govt. entities with respect to technical equipment/s involved if any.

5.To ensure that manpower including PI & Co-PI are dedicated only to research project during its implementation and their professional charges earned for research project from Govt. grants do not violate the service conditions of Govt. organizations (Fully aided / grant-in-aid institutions).

6. In such an eventuality it will be the responsibility of party of second part to submit the No Objection Certificate (NOC) from employer institutes/host institutes.

7. The proposal will be submitted on-line in standard template with undertaking to fulfill all commitments in template, due diligence and this MoU document.

8. The progress reports agreed as per the Phase-I, II& III or relevant to project shall be submitted before lodging the claim for release of grants.

9. Documentation process for submission along with the utilization certificate for the grants shall be submitted in the prescribed format by Accounts Department TRTI Pune.

10. The complete research documentation shall be submitted inclusive of publication of books, articles and promotional material for propagating the research

given in standard template. 12. To create and register intellectual property in the name of TRTI Pune. In case the simultaneous registration of the property in the name of TRTI Pune is not possible, transfer the ownership after the conclusion of project.

conclusion of project. 13. To transfer the royalty/share of earning if the intellectual property is utilized jointly with some other IP created by proposer institute or its other clientele.

20. The party of second part shall fulfill all the terms and conditions of Tribal Development Dept. Govt. of Maharashtra and in the absence of same the terms stipulated in the policy of Ministry of Tribal Welfare Govt. of India shall be automatically made applicable.
